Many members vote by absentee ballot.

If your project receives the majority vote and you are awarded funds from the Golden Goose Club, invoices must be presented for payment to our treasurer within two years of receiving the vote for funds. It is not the responsibility, nor the intention, of the Golden Goose Club to remind anyone of that deadline. If invoices have not been presented within two years, and we have not received a sufficient reason for an extension on or before that two year deadline, the funds will remain the property of the Golden Goose Club, as if you were never awarded the funds. If, an extension is requested on or before that two year deadline, it will be put to a vote of the members before an extension can be approved. When funding is forfeited, those funds will be added to the current quarter. You may be eligible to reapply for funding of your project at a future meeting. If applicable, please discuss your situation with any board member. Contact information for all board members is located at the end of this form.

The final decision for funding any project is subject to membership approval.
